

**RECORD OF PROCEEDINGS; MINUTES OF THE VILLAGE OF LEWISBURG, OHIO, REGULAR COUNCIL MET AT 7:30 P.M., OCTOBER 2, 2014 AT THE FIREHOUSE**

The regular meeting of the Village of Lewisburg, Ohio and Council was called to order at 7:30 PM by Mayor Pat Putnam.

Municipal Manager reported that he attended a recent Ohio Department of Transportation meeting and St. Rt. 503 through the Village is scheduled for paving in the year of 2016.
