

RESOLUTION NO. 2015 - 06

RESOLUTION REQUESTING THE PREBLE COUNTY, OHIO, AUDITOR TO CERTIFY THE TOTAL CURRENT TAX VALUATION OF THE VILLAGE OF LEWISBURG, PREBLE COUNTY, OHIO, AND THE AMOUNT TO BE GENERATED DURING THE FIRST YEAR OF COLLECTION OF A 1.0 MILL RENEWAL TAX LEVY FOR THE CURRENT EXPENSES OF THE BROWN MEMORIAL LIBRARY, A MUNICIPAL PUBLIC LIBRARY OF THE VILLAGE OF LEWISBURG, PREBLE COUNTY, OHIO, AS PER OHIO REVISED CODE SECTIONS 5705.03 AND 5705.23

That Whereas, the Board of Trustees of the Brown Memorial Library have initiated proceedings for the submission to the electors of the Village of Lewisburg, Preble County, Ohio, at the 2015 General Election to be held on November 3, 2015, the question of a 1.0 mill renewal tax levy for a five-year period of time for current expenses of said Brown Memorial Library;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF LEWISBURG, PREBLE COUNTY, OHIO, TWO-THIRDS OR MORE OF ALL OF ITS MEMBERS THEREOF CONCURRING, AS FOLLOWS:

Section 1. That it is necessary to assess a 1.0 mill renewal tax levy for current expenses of the Brown Memorial Library, a municipal public library of the Village of Lewisburg, Preble County, Ohio, for a five-year period of time, and that the Board of Trustees of said Brown Memorial Library have initiated these proceedings by appropriate Resolution(s). The renewal is for a levy currently expiring in tax year 2014 (collected in calendar year 2015).

Section 2. That the Preble County, Ohio, Auditor is hereby requested to certify the total current tax valuation of the Village of Lewisburg, Preble County, Ohio, and the amount to be generated during the first year of collection of a renewal tax levy for the current expenses of said Brown Memorial Library at a rate not exceeding 1.0 mills for each one dollar of valuation, which amounts to 10 cents (\$0.10) for each one hundred dollars of valuation, as per Ohio Revised Code Sections 5705.03 and 5705.23.

Section 3. That the Clerk of Council is hereby authorized and directed to deliver a certified copy of this Resolution to the Preble County, Ohio, Auditor.

Section 4. That it is hereby found and determined that all formal actions of this Village Council concerning and relating to the adoption of this Resolution were taken in an open meeting of said Village Council, and that all deliberations of said Village Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5. That this Resolution shall be effective from and after the earliest period allowed by law.
