## RECORD OF PROCEEDINGS; MINUTES OF THE VILLAGE OF LEWISBURG, OHIO, REGULAR COUNCIL MET AT 7:30 P.M., AUGUST 21, 2014 AT THE FIREHOUSE

The regular meeting of the Village of Lewisburg, Ohio and the Council was called to order at 7:30 PM by Council President Marsha Jones.

**PRESENT:** Five members were present. Mayor Pat Putnam was absent. Municipal Manager Sewert was also present.

Motion to approve the minutes from the August 7, 2014 regular Village Council Meeting. First by Belinda Harry. Second by Don Wrigfht. Vote: 4 Yes 0 No 1 Abstain (Marsha Jones). The check disbursement report was reviewed by council.

**MAYOR:** Council President Jones read a note from Mayor Putnam thanking all those involved in making Derby Days another success.

**MUNICIPAL MANAGER:** Manager Sewert has met with Larry Rike regarding his property on Cumberland Street. We are working towards an agreement that would include the marketing of the property. Any agreement made will be in writing.

We are close to completing the WWTP project. The clarifier is being readied for start up. The affluent is producing clear, quality water.

The Cumberland Street project is close to its final out. The dirt work is all that is left.

The Clay Street – Pratt project started Monday with the water line work. We are keeping one lane open for truck traffic.

Once again ODOT has denied the Second and Third Street improvement project. We will not pursue this grant again.

We are waiting for the signatures from P&G, Cargill, and Provimi to complete the transition of the south water/WWTP.

Manager Sewert thanked Park Harry on behalf of the village for the many hours he has spent on making Derby Days a success.

Manager Sewert requested to go into executive session at the end of the meeting for the purpose of acquiring real estate.

**SAFETY:** Chief Sewert thanked the Police Department for taking care of the parking and rerouting of traffic during Derby Days.

Randy Anderson was able to recruit possibly five more people for the cadet program.

Vectren is in the village repairing /replacing 18 gas lines. They were notified of the odor of gas in front of the firehouse.

**POLICE:** Law Director Faber stated that the resignation letter from Jessica Begoon needs to be signed before council can approve the resignation.

Manager Sewert thanked the Police Department for their professionalism in handling Derby Days.

**LIBRARY**: An open house has been scheduled for September 6<sup>th</sup> from 11:00AM to 2:00 PM.

**PARK**.: The Park Board would like to have the gazebo sealed as well as the sculpture and the foot bridge before winter.

Manager Sewert will be looking into a grant to restore the creek banks.

The last movie in the park will be September 6<sup>th</sup>.

A big "thank you" goes out to Sandy Heindl who single-handed designed and put the float for Derby Days together.
