

RESOLUTION NO. 2020 - 09

LEWISBURG, OHIO, RESOLUTION TO PARTICIPATE IN THE RECEIPT OF FUNDS RESULTING FROM THE "CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT" AND TO CREATE A LEWISBURG LOCAL CORONAVIRUS RELIEF FUND TO ACCOUNT FOR FUNDS RECEIVED AND DISBURSED

THAT WHEREAS, the Coronavirus Aid, Relief, and Economic Security Act, 116 Public Law 136, (the CARES Act) was signed into law by the President of the United States on March 27, 2020; and

WHEREAS, the Ohio General Assembly established a process for distributing funds provided by the "Coronavirus Aid, Relief, and Economic Security Act" in H.B. 481 of the 133rd General Assembly (H.B. 481); and

WHEREAS, H.B. 481 requires subdivisions receiving funds under Section 1 of the act, to pass a resolution affirming that funds from the County Coronavirus Relief Distribution Fund may be expended only to cover costs of the subdivision consistent with the requirements of section 5001 of the CARES Act as described in 42 U.S.C. 801(d), and any applicable regulations before receiving said funds; and

WHEREAS, the Village of Lewisburg, Ohio, is requesting its share of funds from the County Coronavirus Relief Distribution Fund;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF LEWISBURG, PREBLE COUNTY, OHIO, AS FOLLOWS:

Section 1. The Village of Lewisburg, Ohio, Council herein affirms that all funds received from the County Coronavirus Relief Distribution Fund pursuant to H.B. 481 shall be expended only to cover costs of the subdivision consistent with the requirements of section 5001 of the CARES Act as described in 42 U.S.C. 801(d), and any applicable regulations and guidance only to cover expenses that:

- A. Are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19);
- B. Were not accounted for in the Village of Lewisburg, Ohio's, most recently approved budget as of March 27, 2020;
- C. Were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020.

Section 2. The Village of Lewisburg, Ohio, Fiscal Officer shall take all necessary action to:

- A. Create and establish a local coronavirus relief fund for the Village of Lewisburg, Ohio, from which all relevant funds shall be receipted into and all appropriate expenditures disbursed from;
- B. On or before October 15, 2020, pay any unencumbered balance of money in the Village of Lewisburg, Ohio's local coronavirus relief fund to the County Treasurer;
- C. On or before December 28, 2020, pay the balance of any money in the Village of Lewisburg, Ohio's local coronavirus relief fund to the state treasury in the manner prescribed by the Director of the Ohio Office of Budget and Management;
- D. Provide any information related to any payments received under H.B. 481 to the Director of the Ohio Office of Budget and Management as requested.

Section 3. The Village of Lewisburg, Preble County, Ohio, Clerk of Council shall certify a copy of this Resolution to the Preble County, Ohio, Auditor and the State of Ohio Director of Budget and Management.

Section 4. This Resolution shall be effective from and after the earliest period allowed by law.
