

**ORDINANCE AMENDING CHAPTER 181 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF LEWISBURG, PREBLE COUNTY, OHIO, ENTITLED "INCOME TAX", THE PRIMARY PURPOSE OF WHICH IS TO RAISE THE VILLAGE INCOME TAX RATE FROM ONE AND ONE-HALF PERCENT (1.5%) TO ONE AND THREE-QUARTERS PERCENT (1.75%), WITH FUNDS RAISED FROM SAID ONE-QUARTER OF ONE PERCENT (.25%) INCREASE EARMARKED FOR THE PURPOSE OF CAPITAL IMPROVEMENTS FOR SAID VILLAGE**

That Whereas, current Lewisburg Village income tax revenues are deemed inadequate to meet the ongoing needs of the Village, particularly in the area of Capital Improvements;

And Whereas, it is useful and appropriate for the Village of Lewisburg to have an increase in its Income Tax rate;


**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF LEWISBURG, PREBLE COUNTY, OHIO, AS FOLLOWS:**

**Section 1.** Chapter 181 of the Codified Ordinances of the Village of Lewisburg, Preble County, Ohio, entitled "Income Tax", currently reads as the attached Exhibit "A" (pages numbered 53 to 82).

**Section 2.** Chapter 181 of the Codified Ordinances of the Village of Lewisburg, Preble County, Ohio, entitled "Income Tax", is herein amended in its entirety to read as the attached Exhibit "B" (pages numbered 1 to 26).

**Section 3.** This Ordinance shall become effective from and after January 1, 2016, provided that a majority of the electors of the Village of Lewisburg, Preble County, Ohio, voting at the General Election on Tuesday, November 3, 2015, approve this Ordinance.


