

RESOLUTION NO. 2019 - 16

A RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION WITH THE STATE OF OHIO TO PARTICIPATE IN THE SMALL CITIES COMMUNITY DEVELOPMENT BLOCK GRANT, TARGET OF OPPORTUNITY DOWNTOWN BUILDINGS PROGRAM; AUTHORIZING THE MUNICIPAL MANAGER TO EXECUTE SUCH APPLICATION; AND THE HIRING OF MOTE AND ASSOCIATES, INC. TO HANDLE THE APPLICATION AND ENGINEERING ASPECTS OF THE PROJECT.

That Whereas, the State of Ohio, Development Services Agency, provides financial assistance to local governments for the purpose of addressing local development needs;

And Whereas, the Village of Lewisburg, Ohio desires to participate in the program to receive financial assistance for improvements to downtown buildings;

And Whereas, the Village of Lewisburg, Ohio has the authority to apply for financial assistance and to administer the amounts received from the State of Ohio, Development Services Agency through its Small Cities Community Development Block Grant, Target of Opportunity Downtown Buildings Program;

And Whereas, the Village Council of the Village of Lewisburg must direct and authorize the Municipal Manager to act in connection with the application and to provide such additional information as may be required.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF LEWISBURG, PREBLE COUNTY, OHIO, AS FOLLOWS:

Section 1. That the Council of the Village of Lewisburg hereby authorizes the Municipal Manager to act as the official representative of the Village of Lewisburg in connection with the Village's application to participate in the State of Ohio, Development Services Agency, Target of Opportunity Downtown Buildings Program, and provide all information and documentation required in said application for submission.

Section 2. That the Council of the Village of Lewisburg, Ohio hereby approves the filing of an application for financial assistance through the Ohio Small Cities Community Development Block Grant, Target of Opportunity Downtown Buildings Program.

Section 3. That the Council of the Village of Lewisburg, Ohio hereby understands and agrees that participation in the Program will require compliance with Program guidelines and assurances.

Section 4. That the Council of the Village of Lewisburg, Ohio hereby authorizes Mote and Associates, Inc. to assist the Village in its application process and in the grant administration and engineering aspects of the project.

Section 4. This Resolution shall be effective from and after the earliest period allowed by law.
