

RESOLUTION ADOPTED PURSUANT TO OHIO REVISED CODE SECTION 5705.03 IN PREPARATION TO PLACING A TAX LEVY ON THE BALLOT AT THE NOVEMBER, 2018, GENERAL ELECTION

That Whereas, the Village of Lewisburg, Preble County, Ohio, Village Council wishes to submit a tax levy to its voters at the November, 2018, General Election;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF LEWISBURG, PREBLE COUNTY, OHIO, AS FOLLOWS:

Section 1. The Village Council wishes to place an additional outside millage tax levy on the November 6, 2018, General Election ballot for its citizens to decide. The additional millage amount will be 2.25 mills, to commence in calendar 2018 (collected in calendar year 2019), and it is to be run for a five year period of time. The 2018 General Election ballot has been chosen under the authority contained in Section 5705.19 of the Ohio Revised Code and other applicable law. The tax shall be levied upon the entire territory of the Village of Lewisburg, Preble County, Ohio, and the ballot measure shall also be submitted to the entire territory of the Village of Lewisburg, Preble County, Ohio, for approval.

For providing and maintaining motor vehicles, communications, other equipment, buildings, and sites for such buildings used directly in the operation of a police department, for the payment of salaries of permanent or part-time police, communications, or administrative personnel to operate the same, including the payment of any employer contributions required for such personnel under section 145.48 or 742.33 of the Revised Code, or for the payment of other related costs.

Section 3. This Resolution requests a prompt response from the Preble County, Ohio, Auditor per Section 5705.03 of the Ohio Revised Code, certifying the total current tax valuation of Lewisburg, Ohio, and the dollar amount of revenue that would be generated by said 2.25 mills. Any other appropriate or necessary information from the County Auditor is welcome and acceptable in the response.

Section 4. The Clerk of Council is hereby authorized and directed to certify this Resolution and deliver a certified copy to the County Auditor forthwith.

Section 5. That it is hereby found and determined that all formal actions of this Village Council concerning and relating to the adoption of this Resolution were taken in an open meeting of said Village Council, and that all deliberations of said Village Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution shall be effective from and after the earliest period allowed by law.
